Subject: Regarding Pending Payment of Rs. 28,00,000 from TSQLHWA (Tamilnadu Stone Quarry Lease Holders Welfare Association)

I am writing to bring to your kind notice of the delay in payment by **TSQLHWA (Tamilnadu Stone Quarry Lease Holders Welfare Association)** for an exhibition event we successfully organized on Sep 29th and 30th , 2024 , titled "**IMEC'5 – International Mining Expo and Conclave**) at **Chennai Trade Centre - CTC.**"

1. The event was executed as per the instructions given by the Association, and all work was completed diligently and in accordance with our proof.
2. However, a payment of Rs. 28,00,000, which is meant to be allocated to various vendors involved in the event, is still pending.
3. Despite our repeated follow-ups and numerous requests made to the Association for the release of the pending payment, there has been no solution found for the payment.
4. We have also met with the **former Chairman, Mr. Jayaraman, TSQLHWA** (Contact No: 7711990666) for the payment at his office for so many times, but we were informed that it would be done. Unfortunately, no action has been taken as of now.
5. He has continually postponed the payment, assuring us that it would be processed "tomorrow," but this promise has not been fulfilled for over two months.
6. Whenever we tried calling **Mr. Jayaraman, his Manager Mr. Santhosh (Contact No: 9994783838)** is the one who is answering the phone and no reliable solution has been given to us so far.
7. All relevant documents and financial records related to the event have been provided to the Association and its members, but they are unnecessarily delaying the payment.
8. This prolonged delay has caused severe distress and financial difficulties for us and our vendors.

9. We are under immense pressure from the vendors, who are demanding immediate payment, and we are unable to resolve the situation due to the Association's failure to settle pending payment.
10. Every day, nearly 40 vendors are calling and pressuring us for the payment as they have to settle payments for their vendors and employees.
11. The pressure is increasing day by day, causing significant operational disruption, tension, and undue stress.
12. As a result of the ongoing delay, financial hardship, and increasing pressure, we are unable to manage the situation any longer.
13. We kindly request your intervention in resolving this matter and facilitating the release of the pending payment of Rs. 28,00,000 from the Association.
14. I request your assistance in investigating this issue and ensuring that the payment is made at the earliest to settle the outstanding dues.
15. Attached are all relevant documents, including contracts, payment requests, and correspondence with the Association, as evidence of our efforts to resolve this issue amicably.

I kindly request you to look into this matter and take the necessary action to recover the amount owed to us. Thank you for your consideration. I look forward to your prompt support and intervention.
