Subject: Complaint Regarding Pending Payment by Mr. Jayaraman , Former Chairman of TSQLHWA(Tamilnadu Stone Quarry Lease Holder Welfare Association)
Respected Sir/Madam,

We are writing to bring to your kind notice a complaint regarding a payment dispute with **Mr.Jayaraman , President of TSQLHWA**, related to the event "IMEC'5,"- International Mining Expo and Conclave) which was held on the 29th and 30th Sep 2024 at **CTC – Chennai Trade Centre, Chennai.**

- The letter is dated on 19.12.2014
- 1. Mr. Jayaraman engaged our services for a Television Advertisement and Registration for the **Expo IMEC'5- International Mining Expo and Conclave** held on 29th and 30th Sep, 2024 at CTC- Chennai Trade Centre , for a **total agreed amount of Rs. 9,61,000 for TV AD and 3,25,000 for Registration Service, totally of Rs.12,86,000 for both services.**
- 2. Upon confirmation from Mr. Jayaraman, we commenced our work and delivered the TV Advertisement and Registration process as per the agreement.
- 3. After completion of the TV advertisement and Registration Process for **IMEC'5** , Mr. Jayaraman , (Contact No:7711990666) released only Rs.7,00,000 for TV AD and 1,50,000 for Registration.
- 4. Despite repeated reminders over the past two and a half months, the remaining amount of **Rs.2,61,000 for TV AD and Rs. 1,75,000 for Registration** is yet to be paid.

5. Whenever we attempt to contact him, Mr. Jayaraman)does not answer our calls. His Manager , Mr. Santhosh , (**Contact No:9994783838**) occasionally responds but only offers vague excuses, stating that the payment will be processed soon.
6. No steps have been initiated to release the pending payment.
7. We are under tremendous pressure as we need this payment to settle dues with our vendors.
8. Daily visits and repeated calls from vendors demanding their payments have disrupted our office environment, making it difficult for us to focus on our work. This has caused immense stress and negatively impacted our team.
9. The mounting pressure from vendors has become unbearable.
10. We possess all necessary documentation and recorded telephonic communications with Mr.Jayaraman and his team as evidence of the agreement and their assurances.

We kindly request your assistance in addressing this matter and facilitating the release of the pending payment of **Rs.4,36,000**. Your intervention will help us resolve this issue and allow us to continue our business without further disruption.
